



# Comprehensive Health Insurance for Foreigners – quickly and electronically



In connection with the amendment of the **Act on the Residence of Foreign Nationals**, MARSH is now offering the on-line possibility of arranging for **Comprehensive Health Insurance for Foreigners with VZP Insurance Company**.

This insurance complies with the new legislation and fulfils the conditions for acquiring the applicable residency permit for the Czech Republic.

In addition, this insurance guarantees the provision of health care at over **4 500 partner health care institutions** without the need for direct payment.

## What is covered

Comprehensive Health Insurance for Foreigners ensures health care coverage at a level comparable to that of the Czech public health insurance system, covering preventative check-ups and vaccinations, payment for prescriptions and health care equipment and acute dental work, as well as pre- and post-natal care for mother and child.

The insurance coverage can be negotiated for a period lasting between four months and three years. The coverage is valid for the Czech Republic and can also be extended to the rest of the Schengen area.

For stays of up to **90 days** we offer **Basic Health Insurance for Foreigners**, which covers essential and urgent health care.

## How to order

- Application must be filled out for each person to be covered
- Download the Insurance Application pdf form or fill out the form electronically - links on our webpage [www.marsh.cz](http://www.marsh.cz)
- Fill in the start and end date of coverage: start at least 1 day after the date of ordering (please count on payment of the insurance) - minimum length of coverage is set at 4 months, maximum 3 years
- The basic coverage limit is CZK 1 600 000; if you would like to increase it to CZK 2 000 000, check off “Increase limit”
- Choose the type of insurance – supplementary insurance for professional sports, treatment costs for Schengen area or supplementary insurance for newborns
- **Send the filled-out, signed and scanned form to the e-mail address: [milan.jaros@marsh.com](mailto:milan.jaros@marsh.com)**
- A payment request will be sent to you electronically
- After the payment is received we will send you an insurance contract, the insurance conditions and your policy-holder card
- **You will return to us signed policy**
